

ACTION ALERT!

To all who want to preserve beautiful, natural McLaren Park

Thanks for your efforts to help Save McLaren Park from the installation of a Disc Golf Course. It is very important for our concerns to be heard! An effective tool for winning political battles is to write a personal letter (if you type it, please *handwrite* your signature) and then send it snail mail, fax, or e-mail. This makes a real impression on the receiver.

Please write to the four city officials listed below. Include your own personal comments and concerns that come from your heart which could include:

- Your anger/disgust/sadness/? that in 2005, Rec/Pk approved the construction of the disc course without adequately notifying the McLaren Park neighbors! (In 1997, the community was notified and had time to voice their concerns before the decision was made.)
- how you use the park
- what you love about the park-as it is
- concerns about the environmental impact the Disc Golf Course will have
- concerns about the compatibility of the course with current passive recreational activities

It is important to also state the following three demands:

- DECLARE AN IMMEDIATE **MORATORIUM** ON ANY LEGAL AGREEMENT WITH THE SF DISC GOLF CLUB FOR THE CONSTRUCTION OF A COURSE IN MCLAREN PARK
- CONDUCT A FULL **PUBLIC NOTIFICATION** and INPUT PROCESS
- COMMIT TO A FULL STUDY OF THE **ENVIRONMENTAL IMPACT** OF A DISC GOLF COURSE
